

## Understanding Your Rescue Payout

At XRP Recovery, we prioritise the protection of our community and to ensure fair compensation for those affected by scams or rug pulls on the XRPL. To achieve this, we've implemented a structured approach to calculating rescue payouts that are both transparent and equitable.

Our rescue payout process operates under three key levels of protection:

1. **Maximum Total Payout Cap:** The maximum payout for any rescue operation is capped at 5 billion Chit tokens.
2. **Maximum Individual Payout:** The maximum payout to any single wallet is capped at \$1,000 worth of Ching tokens.
3. **Tiered Payouts:** Payouts are adjusted based on the percentage of your current wallet balance relative to the snapshot balance.

Here's a detailed breakdown of how we calculate your rescue payout:

### Step 1: Identifying Eligible Tokens

We start by matching your wallet address with the ones recorded in our snapshots for tokens eligible for compensation.

Next, we check if your wallet has a Trust Line established for the token. If a Trust Line is not detected, we will still process the compensation, but your payout will be adjusted according to the tiered payment structure outlined in Step 4. If a Trust Line is found, we then compare your current token balance with the balance at the time of the snapshot, taken when the token was flagged as a scam.

### Step 2: Calculating the Initial Rescue Supply

Next, we calculate the total amount of tokens required for the rescue operation using the following formula:

$$\text{Initial Rescue Supply} = \frac{d \times (e \times f)}{b}$$

This calculation gives us an initial estimate of how many tokens would be needed to compensate all holders based on the parameters above.

### Step 3: Applying the Maximum Total Payout Cap

If the initial rescue supply exceeds the 5 billion Chit token cap, we adjust the compensation rate to fit within this limit. The adjusted rate ensures that the total payout remains sustainable and within our predefined limits.

$$\text{Adjusted Rate} = \frac{g \times b}{e \times f}$$

## Step 4: Tiered Payout Adjustments

We understand that different wallets may have different balances relative to the snapshot. To account for this, we apply tiered adjustments to your payout based on its percentage relative to the snapshot balance:

- **Below 25%:** Your payout is adjusted to 25% of the original compensation.
- **25% - 50%:** Your payout is adjusted to 50% of the original compensation.
- **50% - 75%:** Your payout is adjusted to 75% of the original compensation.
- **75% -100%:** You receive 100% of your compensation.

These adjustments ensure that payouts are fair and proportional to your original holdings.

## Step 5: Calculating Your Compensation

With the adjusted rate and balance in place, we calculate your compensation in CHIT using the following formula:

$$\text{Your Chit Compensation} = \frac{j \times (e \times f)}{b} \div (e \times i)$$

The corresponding amount of Ching is then calculated based on the Chit-Ching ratio.

## Step 6: Enforcing the Maximum Individual Payout

To ensure no individual receives more than \$1,000 worth of Ching tokens, we calculate the maximum Chit that can be distributed based on the current XRP and Ching prices. If your calculated Ching compensation exceeds this amount, it is capped accordingly.

$$\text{Max Chit Rescue} = \left(\frac{h \div a}{b}\right) \times c$$

This step ensures that all payouts are equitable and within the \$1,000 limit.

## Legend

**a = XRP**

This is the current price of XRP.

**b = Ching**

This is the current price of CHING in XRP.

**c = Chit-Ching Ratio**

This is the ratio at which we will convert Chit to Ching following the 6-month Trust Line Freeze.

**d = Rate of Rescue**

This is the rate of compensation that you will receive on your investment.

**e = Token Supply**

This is the total amount of tokens for the project being rescued.

**f = IDO Token Price**

This is the launch price of the token being rescued.

**g = Payout Cap**

This is the maximum amount of tokens any one project can receive in compensation (5 billion Chit tokens).

**h = Dollar Cap**

This is the maximum amount of compensation any one wallet can receive in Ching (\$1,000).

**i = Adjusted Balance**

This is the amount of tokens we base your calculation on if your current token holding varies from the snapshot we have on file.

**j = Adjusted Rate**

This is the Rate of Rescue we use that ensures your compensation complies with the various safeguards we have.
